Firstly, I researched about Bachelor of Business Accounting in my country Nepal, I found that there were many institutions such as College Name which offers four years in Bachelor of Business Administration (BBA) program. http://www.abc.com (include college link). College Name designed to produce professional managers and entrepreneurs by providing students with sound conceptual foundation and practical skills in business communication, business management, strategic management, fundamental of entrepreneurship, business environment in Nepal, but it does not focus in accounting. So, I decided to research about more colleges such as College Name, they offer four years of

Bachelor of Business Administration. which is considered the best management college in Nepal that has established the best career track records after graduation in Bachelor of Business Administration https://abc.com (include college link). But as similar to College Name it does not give deep knowledge about accounting. College Name provides three years of Bachelor of Business Administration (International Business). The course is only designed to provide student a knowledge of changing needs related to dynamic international business environment as well as the competitive global markets. Colleges like College Name, College Name, College Name and College Name have extraordinary courses in relation to the field of Business Administration, but I did not want to participate in their program as they only offer four years course that was lacking Business Accounting major. After very careful observations and consulting with my family I was advised that it will be better for me to try to find something that is unique and search for colleges that has better reputation with a well organized degree structure with more detailed information and focused courses which is more related to accounting.

Although, I have many options related to Bachelor's in Business studies and Administration, I decided not to pursue my higher education in Nepal because it's not above par. I was not able to find any colleges that offer majoring in Business Accounting. I was completely disappointed that none of them actually matched the criteria I was looking for. Colleges in Nepal and Universities are more focused on theoretical aspects rather than practical. I have always thought about studying on a global scale and implement on my country which lacks here in my country. Also, courses are outdated which has been taught the same course from decades to students. I also found graduates from these institutions has less chances of job placement after completion of the course. Some foreign-affiliated colleges such as college name, College Name, College Name have administrative problems, inconsistencies in free structures; many of these colleges have not properly mentioned how much fees are collected from each student. The graduators in business accounting has a great career in Nepal but education in Nepal in this field is still not satisfied. Thus, I decided not to compromise with the quality of education need for my successful career. Therefore, I started doing research about neighboring country India

In India there are numerous universities, that offers Bachelor of Business with accounting.

Name of University (college in india), offers three years of Bachelor of accounting and Finance (Hons). The course focused on balance preparation of career in accounting, finance and entrepreneurship providing knowledge of Financial Skills and Numeracy, Financial Accounting, Cost Management Accounting, Accounting in Business, Financial Reporting

https://abc.com/. Name Of University offers three years of Bachelor of Commerce (Hons). The course focused in trade and commerce providing knowledges on Accounting, Finance practices

All of these universities provide impressive education in accounting, but I decided not to study in India. I found admission in these India's top ranked institutes is highly competitive and seats available is quite limited. It sometimes takes more than a year to get into Indian's school with the education system not being above par and I found similarity in Nepal's and India's university as well. On top of that, bullying in many universities is very common in India which are affecting students physically and mentally and ultimately it will affect my study as well. Colleges in India lacks opportunities for practical knowledge. Indian education systems emphasis on note learning and less practical assessments to remember concepts rather than applying them. Therefore, I decided to explore other institutions and countries such as United Kingdom.

Name of University offers BSc in Accounting and Business. The top 9th best universities in the United Kingdom which is listed for Accounting and Finance in the complete University Guide 2020 with No. 1 UK business school for graduation employment. After looking at all the courses taught in this institution, I was really impressed by their course content and wanted to pursue there but the tuition fees are very high. xxxx pounds a year which is out of my budget. Name of University offers BSc Accounting and Management (NN42). The course equips with the attributes to pursue a wide range of accounting, consultant and managerial career paths. The core contents fundamental of accounting and finance 1 and 2, quantitative analysis in management, introduction to management, accounting and finance in context. The tuition fees is xx,xxx pounds, which is also expensive https://www.abc.com. Name of University, Name of country, offers BSc Accounting. The three years program structure includes: Principles of Accounting, Accounting Software Applications, Intermediate Accounting, Managerial & Costs Accounting, Introduction to Taxation, Advanced Accounting. The program prepares the student for a wide variety of business careers, and help the student to acquire the knowledge, experience and skills and the tuition is xx,xxx pounds https:// www.abc.com. The course and its module were very interesting and would lead the graduate to a wide variety of roles as a business accounting but the tuition is very high for me to afford. Name of University, Name of country, offers Bachelor of Accounting and Finance. The three years of course content introduction of finance accounting, corporate finance, academic and professional development for studies in finance, credit and financial analytics, intermediate financial accounting, intermediate management accounting, contemporary issues in accounting. The course and its module were very interesting, but the tuition is very high for me to afford which is xx,xxx pounds https://www.abc.com and the course start form month, year so, I decided not to choose this university, as I would lose my valuable

time which will affect my study. Therefore, due to its high fees and living expenses I decided not to study there. Another big university in the UK that was offering very impressive Bachelor's degree in Accounting was Name of University https://www.abc.com. This university have an excellent program fully focused on accounting and finance management. Accredited by the Association of Chartered Certified Accountants (ACCA), the Institute of Chartered Accountants in England and Wales (ICAEW), the Chartered Institute of Management Accountants (CIMA) and the Chartered Institute of Public Finance and Accountancy (CIPFA) this college has units like Management Accounting, Financial Accounting, Intermediate management accounting, and xx credit hours on dissertation on the final year of the program. This three-year program is offered at xx,xxx pounds a year which is also not in my budget.

Therefore, after consultation with my family members, friends and advisors they suggested me not to pursue my career in the Name of country due to steady rise in the tuition and also the living expenses in the Name of country is getting very high. Unfortunately, the tuition was very expensive, and I was not able to afford this college as my further education. Another good university in the Name of country was Name of University that offers 4 years of Bachelor of Business Management. The course content has Computer composition, computer and internetworked society, general education, introduction of management accountant, basis economics, analytical methods for business. The cost of tuition fees is USD \$ xx,xxx per annum for xxx credit point, which is very high, also the courses they teach were not what I was looking for as I was fully focusing on accounting as my major

Despite several study options in the Name of country, I decided not to choose the Name of country as my study destination due to their unaffordable tuition fees.
